VINTAGE AND HISTORIC DIVISION Minutes of Regional Representatives' Conference Call – January 10, 2013

The meeting was called to order by Vintage Chairman John Krebs at 8:00 PM EDT. In attendance were Vice Chairman Dave Richardson, Region 1 Donnie McLean, Region 2 Bill DeGlopper and Marv Hart, Region 3 Bob Moore, Region 4 Dan Joseph, Region 6 Ron Snyder, Region 7 Joe Johnson, Region 8 Phil Mitchell, Region 9 Jay Marshall, Region 10 Jim Olson, Region 11 Frank Banducci, Region 14 Roger Hinsdale, Canada Harry Holst. John asked who would be attending the APBA National Meeting in Dallas at the end of January. Those currently planning to attend are John Krebs, Dave Richardson, Jay Marshall and Dan Joseph.

John announced that Dave Richardson will be Chief Referee for V&H for this year. John is actively seeking an individual to be Chief Inspector for V&H but has not received confirmation that the individual will accept the responsibility. Referees, Inspectors, Asst. Risk Managers and Scorers (actually called vintage registrars, those who are responsible for submitting the paperwork for an event) for V&H will need to take the respective tests for these positions. The tests will be available online following the APBA National Meeting.

Debbie Joseph announced the tentative schedule of events for 2013. No conflicts because of distance between events on the same weekend were noted. The tentative schedule submitted follows these minutes.

Next on the agenda was discussion of ways to grow membership in V&H. John noted that V&H showed a decline of 8 members in 2012. Following lengthy discussion, three areas of potential growth were identified. These will be evaluated at ad-hoc meetings in Dallas at the APBA National Meeting:

- 1. Revisit the rule requiring physicals for all V&H participants
- 2. Consider updating the requirement for boats to have been constructed in 1986 or before to participate at V&H events
- 3. Consider adding pre-1945 boats for V&H participation

Duties of the regional representatives were discussed, including the necessity for a regional strategy for growth of V&H events in each rep's particular region. The regional reps section of the vintagehydroplanes.com discussion board remains available for discussion of sensitive issues not appropriate for the public message board.

The next conference call for the regional representative's board will take place on February 7, 2013 at 8:00 PM EST.

The meeting was adjourned at 9:30 PM EDT.
