

COVID-19 SAFETY ACKNOWLEDGEMENT -- LIABILITY WAIVER AND RELEASE OF CLAIMS

COVID-19 SAFETY INFORMATION:

While participating in events held or sponsored by the Ocean Cup LLC, ("Ocean Cup") "social distancing" must be practiced and face coverings worn at all times to reduce the risks of exposure to COVID-19. Job Site Employee Protocols

- The Code Four team will abide by all client COVID-19 protocols and PPE requirements (masks, gloves, temperature screenings, etc.).
- 2. The Code Four leadership team will continually assess the hazards to which workers and our clients may be exposed and make appropriate changes as and when needed.
- Project meetings and site meetings will be discussed in advance with the teams to minimize time in the workspace and ensuring clear understanding prior to entering the client's premises.
- **4.** Limit worksite access to only essential employees directly involved with purpose on the job site.
- **5.** Maintain social distancing of 6 feet between each employee as practicable, depending on the nature of the project.
- **6.** Code Four actively encourages employees to report and safety and/or health concerns.

Employee Protocols

PPE (PERSONAL PROTECTIVE EQUIPMENT)

Good hygiene practices (especially regular hand washing) are the most important habits for minimizing exposure to the virus and Code Four has communicated to its employees the recommended personal protective equipment (PPE) to include the following items:



Hand Sanitizer

We have implemented hand sanitization stations at each entrance to our building, as well as individual sanitizers for each employee. Hand sanitizer is intended for use in conjunction with proper handwashing habits. Sanitizer is selected based on its effectiveness against a broad range of viruses and bacteria.



Disinfecting Wipes + Cleaner

Used to disinfect high-touch surfaces (writing utensils, handrails, telephones, keyboards, etc.).



Social Distancing

All Code Four employees must adhere to all "social distancing" policies as issued by local and federal authorities. As part of social distancing, employees should maintain at least 6 feet of distance between themselves and their coworkers or anyone else in the workplace.

- In person meetings should not include more than 4 employees at a time unless 6 feet of distance between each employee can be reasonably maintained.
- **2.** No more than 5 employees should be in the break room at any given time.
- **3.** We have reorganized our office as needed to ensure at least 6 feet of distance between each employee workstation.



Face Coverings

In the event that maintaining 6 feet of distance between each employee is not practicable, all employees will be required to wear face coverings or masks.

DAILY HEALTH SCREENINGS

Every employee is subject to a daily health screening (symptoms and temperature screening) before entering the building.

Any employee found with COVID-19 symptoms or a fever will be sent home and not allowed to enter any Code Four facility, company vehicle or client facility.

FLEXIBLE WORK OPTIONS

Employees may have the option to work from home if circumstances require it. Work from home opportunities are examined on a case-by-case basis. Examples include:

- Employees who commute using public transportation
- Employees who have limited childcare options due to COVID-19
- Employees who have tested positive for or are caring for a loved one who has tested positive for COVID-19

HYGIENE

- **1.** Code Four will provide a place for all employees to wash and sanitize their hands.
- **2.** We will actively discourage workers from using other workers' tools, phones or other equipment.
- **3.** We will actively discourage employees from shaking hands or engaging in any unnecessary physical contact of any kind.
- **4.** We have instructed employees not to share lunches or any utensils and there will be no shared food in common areas.
- **5.** Employees are instructed to cough/sneeze into a cloth, tissue, or into their elbow and wash hands on a frequent basis.

FACILITY SANITIZATION

Professional cleaning and disinfection of the entire building (including workspaces, kitchens, bathrooms, common areas, hallways, etc.) twice per week. Daily disinfection of high-touch surfaces, bathrooms and kitchens.
